At 7:25 p.m., the meeting reconvened with Solicitor Tilley stating that an executive session was held for the purpose of discussing a proposed settlement to a lawsuit, Joseph A. Myers versus Penn Township, 2001SU01318-08.

NEW BUSINESS:

Solicitor Tilley recommended that the Board consider adopting a motion to resolve the litigation with Joseph A. Myers and the issues surrounding the storm water ponds in Hall Estates and Little Knoll Estates developments with the following terms:

- The Township will accept for dedication the three lots, 20A, 35A, Hall Estates I and 125, Little Knoll Estates.
- Joseph Myers will dedicate and the Township will accept deeds to the access right-of-way to Lots 20A and 35A as shown on the 1989 Hall Estates I resubdivision plan.
- 3. The Township will agree to pay for the installation of the access road and will clear the access. It will also do the repairs and maintenance to the storm water ponds on Lots 20A, 35A and 125.
- 4. The Township and Joseph Myers will agree that proceedings in the case will be stayed for 1 month, till March 19, 2007, to permit him time to prepare and submit signed and notarized deeds of dedication for the three ponds, 20A, 35A and 125, and for the rights-of-way for the access roads to Lots 20A and 35A in Hall Estates I, and for the Township to pass an ordinance accepting the deeds of dedication. This will require that Joseph Myers submit the executed and notarized deeds of dedication to the Township at least 15 days prior to the next Board of Commissioners meeting, which will be by March 4, 2007, so that the Township can review the deeds and prepare and advertise the ordinance necessary to adopt the ponds.
- 5. Upon acceptance of the deeds of dedication for lots 20A, 35A, and 125, and the rights-of-way for lots 20A and 35A, Joseph Myers will mark the litigation settled discontinued and ended with prejudice.
- 6. The parties will sign mutual releases providing as follows:

- a. Township will release Joseph Myers from any further claims for the three storm water ponds, including but not limited to maintenance, repair, construction or design of the ponds.
- The Township will release Joseph Myers from any obligation to construct and maintain the access easements to lots 20A and 35A.
- c. Joseph Myers will release the Township from any further obligations (except those in the settlement agreement) arising from any plans approved to date with respect to the Hall Estates I, Hall Estates II and Little Knoll Estates.

Mr. Tilley further recommended that he be authorized and directed to prepare a settlement agreement in accordance with the terms that were outlined in the proposed motion and that Jeffrey R. Garvick, Township Manager, be authorized to execute those documents necessary to complete the settlement that is contemplated.

Commissioners Felix/Johnson moved that the Board of the Commissioners approve the Solicitor's request for settlement. Motion carried.

MINUTES BOARD OF COMMISSIONERS' PUBLIC MEETING APRIL 16, 2007

CALL TO ORDER - ROLL CALL - DECLARATION OF QUORUM:

The Penn Township Board of Commissioners met in a regular session on Monday, April 16, 2007 at the Penn Township Municipal Building. President Klunk called the meeting to order at 7:00 P.M., with a roll call of members. Present were Commissioners Klunk, Stauffer, Johnson, Felix and Heilman. Also present were Solicitor Tilley, Manager Garvick, Police Chief Gilbert, Engineer Bortner and Zoning Officer Menges.

<u>PLEDGE OF ALLEGIANCE TO THE FLAG FOLLOWED BY A PERIOD OF SILENT MEDITATION:</u>

All in attendance stood for the Pledge of Allegiance to the flag, which was followed by a period of silent meditation.

ANNOUNCEMENTS:

President Klunk announced that, following the public meeting this evening, the Board of Commissioners would convene in an executive session with the Solicitor for the purpose of discussing legal and/or personnel issues.

PERSONS TO BE HEARD/CITIZENS COMMENTS:

Dana Heston, 823 York Street, questioned the Commissioners as to whether or not they are intending to take her property by eminent domain. The Commissioners listened to her comments but offered no response.

APPROVAL OF THE MINUTES FROM THE PREVIOUS MEETING:

The minutes of March 19, 2007 meeting of the Board of Commissioners were approved as presented.

PUBLIC HEARING:

Commissioner Klunk announced that the purpose of the public hearing is to consider amending the Penn Township Zoning Ordinance by including animal hospitals as a Use By Special Exception in the Shopping/Commercial and Industrial zones along with additions to the Ordinance of Definitions and changes in the administration of permits. The public hearing was properly advertised in the Hanover Evening Sun.

Zoning Officer John Menges stated that on April 3, 2007 the York County Planning Commission reviewed the proposed amendments to the Township's Zoning Ordinance. The proposed amendments include the addition of "Animal Hospital" as a

Special Exception use in the Shopping/Commercial and Industrial zones and to revise criteria and terminology pertaining to building permits and zoning permits. Zoning Officer Menges stated, "the staff of the York County Planning Commission recommends that the proposed amendment to the Penn Township Zoning Ordinance be adopted as proposed. The proposed addition of "Animal Hospital" as a Special Exception use in the Shopping/Commercial (S/C) and Industrial (I) Zones is consistent with other similar uses (hospital and child care center, for example) permitted in those zones. The existing Special Exception criteria offers buffering, fencing, landscaping, etc. to protect adjoining uses. The remainder of the proposed amendment is being made to provide appropriate terminology and revisions in the zoning regulations in accordance with the Uniform Construction Code."

The second amendment is to the Ordinance of Definitions. The Township's Ordinance of Definitions includes definitions for all the Township's Ordinances. The amendment includes the additions of definitions for code official, rolloff dumpster and temporary portable storage unit. The Code Official is defined as "also referred to as "Inspector." The Code Official is an individual authorized to enforce the provisions of the Uniform Construction Code (UCC) as well as any other code(s) for which he is duly certified and authorized by the Township to enforce. Also issues appropriate permits." The rolloff dumpster is defined as "a metal storage receptacle used primarily for the temporary storage or deposit of waste materials, including debris, trash, or construction, renovation or demolition waste, and which is transportable such as to be delivered by, rolled off of, and picked up by, a carrying vehicle that allows for the disposal and removal of its contents to a dump site. The term does not include dumpsters which are permanently placed for the collection of normal household trash, such as at commercial locations or apartment complexes." The Temporary Portable Storage Unit is defined as "commonly known as "portable on demand storage" or "PODS". Any mobile container, storage unit, shed like container or other portable structure, other than an accessory building or shed complying with all building codes and land use requirements, that is not permanently affixed to the land; is designed for temporary short term storage; is not intended for human habitation; that can or is used for the storage of personal property of any kind; and which is located for such purposed outside an enclosed building." The definition of temporary portable storage unit definition was amended following review by the Penn Township Planning Commission. Zoning Officer Menges stated, "the staff of the York County Planning Commission recommends that the proposed amendment to the Penn Township Ordinance of Definition to add three (3) new definitions be adopted as proposed, with the exception noted below. The term "Code Official" is utilized by the Uniform Construction Code and is adequately defined. "Rolloff Dumpster" and "Temporary Portable Storage Unit" are new terms recently added to the zoning ordinances of a number of municipalities to address these new uses. The proposed definitions clearly describe the terms, and are also very similar to those recently adopted by those municipalities. Township Officials should consult legal council in regard to the use of the acronym "PODS" within the definition of temporary portable storage unit. It could be viewed as a trademark infringement, since "PODS" is the name of a national company and servicing these units."

Commissioners Heilman/Johnson moved to authorize the Township Manger to prepare and advertise an ordinance for the adoption of the proposed zoning amendment changes along with the Ordinance of Definitions with the exclusion of the term "PODS". The motion was amended to have the Solicitor review the legality of the use of the term of "PODS," in the ordinance. Motion carried.

At this point, President Klunk concluded the Public Hearing.

MINUTES BOARD OF COMMISSIONERS' PUBLIC MEETING AUGUST 20, 2007

CALL TO ORDER - ROLL CALL - DECLARATION OF QUORUM:

The Penn Township Board of Commissioners met in a regular session on Monday, August 20, 2007 at the Penn Township Municipal Building. President Klunk called the meeting to order at 7:00 P.M., with a roll call of members. Present were Commissioners Klunk, Stauffer, Felix, Johnson and Heilman. Also present were Solicitor Tilley, Manager Garvick, Police Chief Gilbert, Engineer Bortner and Zoning Officer Menges.

PLEDGE OF ALLEGIANCE TO THE FLAG FOLLOWED BY A PERIOD OF SILENT MEDITATION:

All in attendance stood for the Pledge of Allegiance to the flag, which was followed by a period of silent meditation.

ANNOUNCEMENTS:

President Klunk announced that, following the public meeting this evening, the Board of Commissioners would convene in an executive session with the Solicitor for the purpose of discussing legal and/or personnel issues. President Klunk also announced that the public hearing scheduled for this evening to discuss the rezoning of 1403 Baltimore Street had been postponed to next month at the request of the applicant. Burkentine and Son Builders.

PERSONS TO BE HEARD/CITIZENS COMMENTS:

Steve Burns, 1190 Baer Avenue, expressed concern about flooding occurring to the rear of his property. He stated that he previously presented a petition requesting that something be done about the situation. Baer Avenue also floods in certain areas. MINUTES BOARD OF COMMISSIONERS' PUBLIC MEETING SEPTEMBER 17, 2007

CALL TO ORDER - ROLL CALL - DECLARATION OF QUORUM:

The Penn Township Board of Commissioners met in a regular session on Monday, September 17, 2007 at the Penn Township Municipal Building. President Klunk called the meeting to order at 7:00 P.M., with a roll call of members. Present were Commissioners Klunk, Stauffer, Felix, Johnson and Heilman. Also present were Solicitor Tilley, Manager Garvick, Police Chief Gilbert, Engineer Bortner and Zoning Officer Menges.

PLEDGE OF ALLEGIANCE TO THE FLAG FOLLOWED BY A PERIOD OF SILENT MEDITATION:

All in attendance stood for the Pledge of Allegiance to the flag, which was followed by a period of silent meditation.

ANNOUNCEMENTS:

President Klunk announced that the public hearing scheduled for this evening to discuss the rezoning of 1403 Baltimore Street had been postponed until November at the request of the applicant, Burkentine and Sons Builders. Anyone that is present for the hearing can present their concerns under the public comment portion of the meeting. President Klunk announced that, following the public meeting this evening, the Board of Commissioners would convene in an executive session with the Solicitor for the purpose of discussing legal and/or personnel issues.

RECOGNITION OF EAGLE SCOUT PROJECT:

At this time Commissioner Klunk recognized Steven A. Kimmey, II for the work he did in getting fire hydrants painted in the Township. Mr. Klunk presented Mr. Kimmey a certificate as he read the following: "certificate of recognition, this honor is bestowed upon Steven A. Kimmey, II in recognition of his volunteer service to the residents of Penn Township by organizing volunteers for the painting of the fire hydrants in box area 12, and is awarded this certificate by the Penn Township Board of Commissioners this 17th day of September 2007." Mr. Klunk thanked Mr. Kimmey for the work that he did. Mr. Kimmey thanked those that helped him to achieve this accomplishment, which will help him attain the eagle scout award.

PERSONS TO BE HEARD/CITIZENS COMMENTS:

George Strucco, 33 Sara Lane, Hanover, PA requested that the Commissioners consider conditional approval of the Martin's Ridge Subdivision plan so that the developer can begin construction on his home. Mr. Strucco stated that he put a contract on a lot in the development in March 2003 with construction to begin in the fall of 2003.

He rented a house in 2004 with the intention of only being there a short time while his new home was being constructed. That was one week prior to DEP imposing a sewer moratorium on the Township. The project was put on hold because of the moratorium and in the spring of this year a project was undertaken that would help alleviate the moratorium. Bon Ton Builders has completed the preliminary work on the site for the plan. According to Mr. Strucco, the plan has been ready for approval since July but has been continually not approved because of one problem or another with the new sewer line. Mr. Strucco stated he is still in his temporary housing and has been informed he will need to vacate the home sixty days after it is sold. Mr. Strucco would like conditional approval of the project so that he can move into his new house before the house he is renting is sold.

Tom McVey, 1411 Baltimore Street, wanted the Commissioners to consider rezoning the whole block along Baltimore Street to shopping commercial if they were going to consider rezoning 1403 Baltimore Street. He stated that there is a problem with traffic for the residential homes located along this street and the rezoning of the entire block would be fairer to the current property owners.

Tony Thomas, 1413 Baltimore Street, stated that he was in favor of rezoning the whole block to shopping commercial since as soon as you cross into West Manheim Township it is shopping commercial. He also agreed that the traffic is a problem.

Mike Dewald, 3 East Court, would not like to see 1403 Baltimore Street rezoned to shopping commercial because it abuts the rear of is property. He would have no buffer from the commercial area. Currently he is buffered by the existing homes and Baltimore Street from the shopping commercial zone. When he moved in 19 years ago the entire area was zoned residential. He does empathize with the neighbors that front Baltimore Street.

James Sheehan, property owner of 60 Bowman Road, would like the Board to consider not awarding the demolition bid of his property. He stated that he purchased the property a year ago at a tax sale and has had some problems, which have prevented him from repairing the structure. He would like more time to be able to correct the problems. He stated that the building is structurally sound and is willing to have some one inspect the property to make sure that it is sound.

Michael Mummert, owner of 40 Bowman Road, stated that the property at 60 Bowman Road has been in disarray for seven years. He would not mind a little time be given to the property owner to repair the structure but not the years they have already had. He stated that he is not able to sell his property because of the condition of the neighboring structure. He stated that there have been rats coming from the structure, children seen smoking marijuana along with trash littering the property. He stated that part of the house fell down onto his property at 40 Bowman Road and because no one was able to contact Mr. Sheehan, Mr. Mummert had to collect funds from the insurance company to remove the structure. He stated that the property looks horrible.

Lillian Jarvis, 5 Orion Court, expressed concern about the neighbors riding four wheelers (ATV's) at all hours of the day and any day of the week on the property next to hers. She stated that she is a nervous wreck and cannot sit outside and enjoy her deck. Commissioner Klunk asked that she speak with Police Chief Gilbert following the meeting to see if he can help address her concerns.

David Shearer, 4052 Grandview Road, stated he felt that the Township needed a nuisance noise ordinance if the Township did not have one already because other townships and boroughs have them.

Janice Sheehan, 60 Bowman Road, refuted some of the statements made by the neighbors at 40 Bowman Road.

Doris Myers, 5157 Grandview Road, was concerned about the water coming of the St. Joseph's School property on to her property. She stated that water has run into her basement and ruined the carpet. She may not be able to sell her property because of the problem. She stated that Conewago Contractors has told her that there is not a problem.

Michael Swartz, 5167 Grandview Road, explained that he also gets water in his basement from the school property and that he did not when he purchased his property in 1969. He stated there were no water issues when the property was farmed, and, later, when the church was built. He stated that when they built the addition to the school it created a lot of water run off and that is when the water problem started. He stated that the school was built about 1988.

Dan Goldsmith, 51 Little Knoll Drive, thanked the Commissioners for having the excessive growth in the retention pond located behind his house taken care of.

<u>APPROVAL OF THE MINUTES FROM THE PREVIOUS MEETING:</u>

Commissioner Johnson noted that the August 20, 2007 minutes under the announcements section on page one should read "Burkentine and Sons" and not "Burkentine and Son". The minutes of August 20, 2007 meeting of the Board of Commissioners were approved as corrected.

PUBLIC HEARING

Commissioner Klunk announced that the purpose of the public hearing is to consider guaranteeing the Penn Township Volunteer Emergency Services loan for a new fire station. The public hearing was properly advertised in the Hanover Evening Sun.

Jeremy Sparks, Captain of the Penn Township Volunteer Emergency Services Association, the newly created volunteer association created from the two former fire companies, the ambulance club and the SCUBA team addressed the Commissioners.

The P.T.V.E.S Association opened bids for the construction of a new fire station. Mr. Sparks did bring along a copy of the plan. The lowest bid for the general contract work was \$3,370,370, the plumbing was \$444,500, and the electrical was \$523,000 for a total of \$4.3 million. There are some other items that include security systems and telephones, which will make the total of the project \$4.9 million. The bids have not been awarded but will be within the month. The station will be located along Clover Lane adjacent to Dr. Lunsford's office and to the rear of Ollie's. It is a four-acre lot with a 30,000 square foot building being proposed. There will be a large engine bay with a tower, office space, bunkrooms and a kitchen. There will be a small piece of undeveloped land to the rear of the property. The building will be residential in appearance.

Manager Garvick stated that the land development plan as been approved and the building is under the commercial review by the Township. Mr. Sparks stated that the contractor should be able to begin within the month.

Mr. Sparks, when questioned by the Board, stated that the original project estimate was \$5.5 million to \$6 million.

Commissioner Heilman stated that the reason the Township is guaranteeing the loan is because the Township is ultimately responsible for fire service to the Township and this will help the fire company stay viable. He does not expect that this ambitious group would have problems paying the loan back.

Mr. Sparks stated that there are no contracts on the current properties but they have sold a small piece of land located near the Frederick Street station. Commissioner Felix noted that it is difficult for the fire company to advertise for the sale of properties since they are not sure when they can vacate them. The proceeds of those sales will be applied to the construction of the new facility. Mr. Sparks noted that none of the current facilities could house all the equipment owned by the association and the Township.

Commissioner Klunk thanked Commissioner Felix for serving as a liaison between the Commissioners and the volunteer association on the building committee. Commissioner Felix thanked the building committee of the fire company for their hard work.

Tony Thomas, 1413 Baltimore Street, stated that Penn Township has a first class fire company and he supports the fire company in the construction of the new fire station.

At this time Commissioner Klunk adjourned the hearing.

George Strucco, 33 Sara Lane, Hanover, PA reiterated that he hopes that the Commissioners will give conditional approval to the Martin's Ridge Subdivision plan so that a building permit can be issued for the construction of his home.

Douglas Gent, 1157 Eichelberger Street, attorney for Bon Ton Builders, expressed concern that conditional approval be given to the Martin's Ridge Subdivision plans so that building permits can be issued for those properties under contract. He stated that with the bonding in place there is no risk to the Township.

INTRODUCION OF THE DIRECTOR OF THE GUTHERIE MEMORIAL LIBRARY

Roberta Greene, the new director of the Gutherie Memorial Library, Hanover's Public Library, introduced herself to the Board and stated that the services and facilities provided at the local library are well received. She stated that about forty-one percent of Penn Township residents have library cards and are using the facility. He felt that they might want to exercise a remedy among themselves to exercise their rights for their property because it may be more successful than the Township pursuing a noise ordinance. He noted that there are neighbor mediation services in York that they may try which could help resolve the issues. Commissioner Klunk stated that it would be difficult for the Board to devise an ordinance but they will review all the options available to them.

APPROVAL OF THE MINUTES FROM THE PREVIOUS MEETING:

The minutes of October 15, 2007 and November 9, 2007 meetings of the Board of Commissioners were approved as presented.

PUBLIC HEARING

President Klunk convened a public hearing to consider a request to rezone a 1.63 acres parcel from Shopping/Commercial (SC) to Urban Residential (R-8). The public hearing was properly advertised in the Hanover Evening Sun.

Zoning Officer Menges reading from the York County Planning Commission minutes stated that the project involves a proposal to rezone a parcel of land in Penn Township (Tax Map 06, Parcel 43B) containing approximately 1.63 acres from

Shopping/Commercial (S/C) to Urban Residential (R-8). This request is being made by Jeffrey Garber and Todd Grim, realtors for Remax located at 1147 Eichelberger Street.

The subject parcel is located in Penn Township on the north side of Manor Street and the south side of Boundary Avenue and is situated to the east of what was previously South Forney Avenue, which has been vacated and no longer provides access from Manor Street to Boundary Avenue. The parcel is presently zoned S/C Shopping Commercial.

The parcel is bordered by the Children's Discovery Day Care Center, zoned Commercial, to the north. KrillCo LLC owns the property to the west. An industrial use storage/garage building is located on the KrillCo property, which is zoned Commercial. The Park Hills Elementary School, zoned R-15 Suburban Residential, is located to the south and Single Family Semi-Detached dwellings, zoned R-8 Urban Residential, are located to the east of the project parcel.

The proposed revision to the map would expand the R-8 Urban Residential Zone to the west of an unnamed alley and extend farther west along Manor Street. This rezoning would enlarge the R-8 Urban Residential District by 1.63 acres and this parcel would be bordered by S/C Shopping Commercial to the north and west and R-15 Suburban Residential to the south.

The parcel is currently an open field and contains a small stream and trees bordering the northern boundary. There are no existing structures on this parcel. Public water and sewer are available at this site.

The Penn Township Comprehensive Plan Future Land Use Map designates the subject parcel as being in the Commercial Primary Growth Area. The Comprehensive Plan designates the subject parcel as having a Current Land Use of Residential.

According to the York County Comprehensive Plan, the subject parcel lies within an Established Primary Growth Area.

The staff of the York County Planning Commission recommends that the proposed rezoning be conditionally approved provided the recommendation noted in Comment #1 below is addressed. Comment # 2 notes the principal reason for support of the recommendation of conditional approval:

1. If the proposed amendment is to be adopted, in order to ensure consistency between the comprehensive plan and zoning ordinance, Township officials should amend the comprehensive plan to reflect the proposed zoning amendment. Section 603 (j) of the Pennsylvania Municipalities Planning Code requires that when "... a municipality amends its zoning ordinance in a manner not generally consistent with its comprehensive plan, it shall concurrently amend its comprehensive plan...." This requirement regarding zoned amendments applies to

- proposed revisions to the zoning map and/or text.
- 2. The location and accessibility of Parcel 43B make it less feasible to be developed commercially than for residential purposes, as it has no direct access to Boundary Avenue, a through street which provides access to a variety of zones and uses. The only accesses to the subject parcel are residential neighborhood streets.

At the Penn Township Planning Commission on September 6, 2007 Planners Van de Castle/Marsh moved for a favorable recommendation to the Penn Township Board of Commissioners on this request. The motion carried on a 7-0 vote.

The applicants are requesting the rezoning to construct a multi family unit, which will require special exception approval from the Zoning Hearing Board. They will also have to submit a land development plan to be reviewed by the Penn Township Planning Commission.

D. J. Hart, attorney for Jeffrey Garber and Todd Grim, represented this request. They have a sales agreement to purchase the property from Mr. and Mrs. Fabian. The property is located between the football field at Park Hills Elementary and the commercial uses located along Boundary Avenue. According to Atty. Hart, this parcel has been denied seven separate commercial uses proposed for this site. There is no commercial access to the property, which is located along a paper alley vacated by the Township. The other properties in the area are generally commercial and residential. The current zoning would allow the parcel to be used as eating establishments, clubs, or other industrial uses. These usages would allow more lot coverage than would be allowed on a residentially zoned property. The applicants provided copies of plans that showed an eight-unit multifamily home for the parcel. A variance was approved for a twelve-unit multifamily home but the project was never followed through.

There was no comment from the public with regards to the rezoning request.

Commissioners Felix/Johnson moved to approve a request dated July 18, 2007 from Jeffrey Garber and Todd Grim to rezone parcel 43B, tax map 06, from shopping/commercial to R-8 urban residential. They further moved to authorize the Township Manager to advertise the appropriate ordinance for adoption by the Board of Commissioners on December 17, 2007. Motion carried 5-0.

Commissioner Klunk adjourned the Public Hearing and resumed the Board of Commissioners meeting.

The Commissioners will be holding a budget meeting on November 28, 2007 at 6:30 PM to review and work on the budget. It was noted that a deficit is not unusual at this time in the budget process.

MINUTES BOARD OF COMMISSIONERS' PUBLIC MEETING DECEMBER 27, 2007

CALL TO ORDER-ROLL CALL-DECLARATION OF QUORUM:

The Penn Township Board of Commissioners met in a regular session on Thursday, December 27, 2007, at the Penn Township Municipal Building. President Klunk called the meeting to order at 7:00 P.M. with a roll call of members. Present were Commissioners Klunk, Felix, Johnson and Heilman. Commissioner Stauffer was absent with notice. Also present was Manager Garvick.

<u>PLEDGE OF ALLEGIANCE TO THE FLAG FOLLOWED BY A PERIOD OF SILENT MEDITATION:</u>

All in attendance stood for the Pledge of Allegiance to the flag, which was followed by a period of silent meditation.

ANNOUNCEMENTS: Commissioner Klunk read the announcement of the executive session held following the Board of Commissioners meeting on December 17, 2007. He announced there would be a personnel session held following the Board of Commissioners meeting this evening to discuss the fireman's contract negotiations.

PUBLIC HEARING 2008 BUDGET:

Commissioners Heilman/Johnson moved that the Manager be authorized to balance all 2007 funds by transferring surplus funds to those accounts showing deficits. Motion carried.

Commissioners Heilman/Johnson moved to adopt Resolution No. 668 setting the rates of pay and various benefits for Management and compensation for other non-

contracted personnel for the calendar year 2008. Motion carried.

Commissioners Heilman/Johnson moved to adopt Resolution No. 669 providing a schedule of fees for permits and services provided by Penn Township. Motion carried.

TOWNSHIP REPORTS - STANDING COMMITTEES:

Finance Committee - Commissioner Heilman

Commissioners Heilman/Johnson moved to approve Township Warrants in the amount of \$696,154.11. Motion carried.

Commissioners Heilman/Johnson moved to adopt Resolution No. 670 appointing Beard Miller Company as Township Auditor and setting compensation for services rendered. Motion carried.

Personnel Committee - Commissioner Heilman

Commissioners Heilman/Johnson moved to ratify the Collective Bargaining Agreement between Penn Township and the Penn Township Patrolmen's Association for the period January 1, 2008 thru December 31, 2011. Motion carried.

Public Works Committee - Commissioner Johnson

Commissioner Johnson had nothing to report.

Planning & Recreation Committee - Commissioner Johnson

Commissioner Johnson had nothing to report.

Health & Sanitation - Commissioner Felix

Commissioners Heilman/Johnson moved to adopt Resolution No. 671, revising the official sewage facilities plan by including the Premier Construction (Gold's Gym) subdivision plan. Motion carried.

Public Safety Committee - Commissioner Heilman

Commissioners Heilman/Johnson moved to adopt the 2008 SPCA stray animal housing and disposal agreement. Motion carried.

OLD BUSINESS:

At this time, the Board readdressed the 2008 budget. Commissioner Heilman stated that he would be willing to vote in favor of the budget so that the Township can

operate at the start of the 2008. He stated that the budget is not a good budget because it is short on the revenue side and there are problems on the expenditure side. These will need to be reviewed by the new board. Most of the items in the budget should and need to be done but there will be problems when they open the 2009 budget. There are large expenditures in the 2008 budget that have already been committed to that cannot be turned back but all the funds are not available to pay for them. Commissioner Heilman felt that a tenth of a mill tax increase would help offset some of the revenue problems. Commissioner Johnson stated that he has concerns about the fire truck, sewer upgrades and expanding the recreation park. Commissioner Klunk stated that the new Board of Commissioners can reopen the 2008 budget. Manager Garvick explained that the Budget can be reopened as it was in 1992. Manager Garvick stated that on January 6, 1992 they decided to reopen the budget and on January 20th, they moved to authorize the advertisement of an ordinance setting a new tax rate and scheduled the adoption of the ordinance at a meeting in February. Manager Garvick stated that the down side is that York County needs the tax rate to prepare the tax bills and they do not know what it is until the municipality tells them.

Commissioners Heilman/Felix moved to reconsider and adopt Ordinance No. 677, the 2008 Budget. Motion carried on a 3-1 vote with Commissioner Johnson casting the dissenting vote.

NEW BUSINESS:

Commissioners Heilman/Johnson moved for the adoption of Ordinance No. 679 Setting the Time and Place of the Regular Meetings of the Penn Township Board of Commissioners for 2008. Motion carried on 4-0 roll call vote.

Commissioner Johnson thanked Commissioner Klunk and Felix for their time served.
